He was also appointed chairman of the Illinois Judicial Conference and as a member of the Special Supreme Court Committee on Capital Cases. Cousins was interviewed by The HistoryMakers® on January 16, 2003, in Chicago, Illinois. This

# Biographical Note by The HistoryMakers®

Like many Chicagoans, William Cousins, Jr., had his roots in the South. Cousins was born in 1927, in Swiftown, Mississippi. His family moved to Memphis, Tennessee and then to Chicago. Cousins graduated from DuSable High School on the city's South Side in 1945. He received his B. A. degree in political science from the University of Illinois, where he graduated with honors in 1948. Cousins then went on to Harvard Law School, receiving his LL.B. in 1951.

Cousins served his country as an infantry lieutenant in the U.S. Army from 1951 to 1953. He continued as an active army reservist for twenty years and retired as a lieutenant colonel. Cousins began practicing law in 1953 as an attorney with the Chicago Title & Trust Company. From 1957 to 1961, he served as a Republican Assistant State's Attorney. Cousins entered private practice with the law firm of Turner, Cousins, Gavin and Watt. In 1967, Cousins was elected as a "Free Democratic" alderman from Chicago's Eighth Ward.

As an alderman, Cousins worked outside of Chicago's powerful political machine and was reelected as an independent until 1976, when he ran for Circuit Court Judge of Cook County and won. Over the next twenty-six years, Cousins presided as a judge on the Illinois Appellate Court and the Cook County Circuit Court. He was also appointed to various positions, including chairman of the Illinois Judicial Conference and as a member of the Special Supreme Court Committee on Capital Cases. While working as a judge, Cousins also served as Chairman of the Illinois Judicial Council, Chairman of the Judicial Council of the National Bar Association and as a Board member of the National Center for State Courts.

Before election to the judiciary, Cousins dedicated his time and talents to an array of organizations and causes, including Chicago Area Planned Parenthood Association and Operation PUSH.

Cousins was a member of Kappa Alpha Psi and Sigma Pi Phi Fraternities, and Trinity United Church of Christ. He was also a member of the halls of fame of the National Bar Association, the Cook County Bar Association, and DuSable High School.

In 2005, Hiroko, Cousins' wife for fifty-two years, made her transition to eternal life. He had four adult children: Cheryl, Noel, Yul and Gail and four grandchildren.

Cousins passed away on January 20, 2018 at age 90.

# **Detailed Description of the Collection**

#### **Series I: Original Interview Footage**

Video Oral History Interview with The Honorable William Cousins, Jr., Section A2003 009 001 001, TRT: 0:30:40?

Appellate court judge William Cousins begins by recalling his family background, describing his parents and discussing the impact of his sister's death while he was a child. Cousins details his early childhood in Swiftown, Mississippi, and Memphis, Tennessee, sharing vivid memories of segregation. He also remembers his high school years in Chicago, Illinois, focusing on jobs he held while in school.

Video Oral History Interview with The Honorable William Cousins, Jr., Section A2003 009 001 002, TRT: 0:29:30?

Appellate court judge William Cousins discusses entrepreneurship in Chicago's African American community. He then describes his high school years, recalling his favorite subjects and activities and explaining his motivation to attend college. Cousins describes his undergraduate experience at the University of Illinois at Champaign-Urbana, focusing on the teachers and mentors who influenced him, and his own drive to work hard towards success.

Video Oral History Interview with The Honorable William Cousins, Jr., Section A2003 009 001 003, TRT: 0:29:50?

Appellate court judge William Cousins continues to recount his undergraduate studies at the University of Illinois Urbana-Champaign, and then explains why he chose to attend Harvard Law School. After detailing his successful years at Harvard, he discusses his military service in Korea, providing examples of race discrimination. Cousins also discusses his marriage to his wife, who is of Japanese descent.

Appellate court judge William Cousins details his career path, describing his work with the Chicago Title and Trust Company as an attorney. He then details his work as a state's attorney fighting corruption in the civil division, and explains why he set up his own private law practice. Cousins then talks about his involvement in Chicago politics, describing 1967 election as alderman for Chicago's 8th Ward, and his election as circuit court judge in 1976.

Appellate court judge William Cousins discusses his affiliation with the Republican Party during the Richard J. Daley Democratic Machine era, and explains why he eventually left the Republican Party to become an independent. He also details his career as a judge for the Cook County Circuit Court and Illinois Appellate Court. He remembers his many successes and explains what made him well-suited for the job. He also discusses an unsuccessful bid to run for the Illinois Supreme Court.
