Abstract: State labor commissioner The Honorable Michael Thurmond (1953 -) was the first

African American to be elected to the Georgia General Assembly from Clarke County since Reconstruction. Later, Thurmond became the first African American elected Georgia State Labor Commissioner, an office he held for over ten years. Thurmond was interviewed by The HistoryMakers® on October 12, 2004, in Atlanta, Georgia. This

Biographical Note by The HistoryMakers®

Georgia Labor Commissioner and noted historian Michael L. Thurmond was born in Athens, Georgia, on January 5, 1953, the youngest of the nine children of Sidney and Vanilla Thurmond. For eleven years Thurmond attended all-black schools, graduating from consolidated Clarke Senior High School in 1971as co-president of the student council and holder of the 100-yard dash record. At Paine College Thurmond started a student paper, was class president, and graduated cum laude with his B.A. degree in philosophy and religion in 1975; he later graduated from the University of South Carolina Law School.

In the summer of 1975, Thurmond helped start the black *Athens Voice* newspaper and upon graduation from law school in 1978, published *A Story Untold: Black Men and Women in Athens History*. Thurmond returned to Athens to practice law and took an active role in civic affairs; in 1986, he became the first African American to be elected to the Georgia General Assembly from Clarke County since the time of Reconstruction. In 1994, Governor Zell Miller selected Thurmond to head Georgia's transition from welfare to work. Thurmond became a distinguished practitioner and lecturer at the University of Georgia's Carl Vinson Institute of Government. Thurmond became the first African American elected Georgia State Labor Commissioner in 1998; in this role he oversaw some four thousand employees while serving 90,000 families.

Thurmond chaired the Martin Luther King, Jr., Georgia State Holiday Commission, and served on the board of curators of the Georgia Historical Society. Thurmond published a second book entitled, Freedom: An African American History of Georgia. Thurmond and his wife Zola raised a daughter, Mikaya.

Detailed Description of the Collection

Series I: Original Interview Footage

Video Oral History Interview with The Honorable Michael Thurmond, Section A2004 199 001 001, TRT: 0:29:29?

The Honorable Michael Thurmond was born on January 5, 1953 in Athens, Georgia. His mother, Vanilla Burton Thurmond, was born in 1921 in Elbert County, Georgia. She traced her ancestry back to a relative enslaved on a plantation in nearby Oconee County. She attended Athens High and Industrial School, took classes at Fort Valley State University, and briefly worked as a schoolteacher before marrying. Thurmond's father, Sidney Thurmond, was born in 1903 in Oconee County, Georgia. He grew up working for a white family to pay off a family debt and never learned to read or write. He worked mainly as a sharecropper, and also sold vegetables, wood, and coal. After the Moore's Ford Bridge Lynching near Oconee County in 1946, his family moved to rural Clarke County, near Athens. Growing up, Thurmond used the newly integrated library of the University of Georgia in Athens to educate himself about black literature and history. Thurmond attended the segregated Lyons Elementary School and Lyons Junior High.

Video Oral History Interview with The Honorable Michael Thurmond, Section A2004 199 001 002, TRT: 0:28:06?

Michael Thurmond aspired to a political career early in life after seeing prominent civil rights leaders in the Atlanta Constitution. Thurmond heard the sound of bombs and sirens following HistoryMaker Charlayne Hunter-Gault's attempted integration of the University of Georgia in 1961. He attended the all-black Burney Harris High School until 1970 when it closed due to desegregation. After fighting to preserve the legacy of, and retain faculty from his former school, Thurmond attended the newly integrated Clarke Central High School in his senior year. Thurmond served as student co-president with a white student and gave a speech that was well-received by both black and white students. His parents' emphasis on education made college a priority for him, and Thurmond attended Methodist Paine College in Augusta, Georgia. Thurmond reflects on the losses incurred by school integration and the historic achievement of sitting in Georgia's first integrated classes. He also remembers influential teachers.

The Honorable Michael Thurmond graduated from Paine College in 1975 then began the Athens Voice, the first local black newspaper since the 19th century. Thurmond graduated from the University of South Carolina School of Law and published his first book, 'A Story Untold: Black Men and Women in Athens History,' in 1978. Thurmond returned to Athens to work in the city attorney's office, then started his own law firm. In 1986 Thurmond became the first African American elected to the Georgia General Assembly since Reconstruction and the only one representing a majority-white district (Clarke

County) in the Southeast. After losing a 1992 run for the U.S. House, Thurmond began his second book, 'Freedom: An African-American History of Georgia, 1733-1865.' In 1994, he was appointed Director of Human Services, Division of Family and Children's Services and tasked with implementing federal welfare reform. Thurmond's 1997 election as Georgia's Labor Commissioner led to modernizing the state's unemployment system.

The Honorable Michael Thurmond met his second wife, Zola Thurmond, while she was working in the office of Georgia Governor Joe Frank Harris. They have one daughter, Mikaya Thurmond. Thurmond wrote his 2003 book, 'Freedom: An African-American History of Georgia, 1733-1865,' to raise awareness of the unknown multitude of enslaved African Americans who resisted slavery and fought for freedom. Thurmond reflects his legacy, and his life. He describes his hopes and concerns for the African American community and how he would like to be remembered.
